# An Investigation Of Corruption

The author of this investigation is founder the philosophy projects [GMODebate.org](https://GMODebate.org) and [Zielenknijper.com](https://Zielenknijper.com) and he is founder and former owner of an „I Love City“ marketing platform with over 200 editors and more than 500,000 social media followers in  Netherlands.



The author is a pioneering innovator (💡 inventor) and in 2014 he was working on a new internet technology that enabled to achieve ‚real instant‘ navigation speed for websites through the use of the Websocket internet protocol. The startup was initially named Websockify and was later renamed to **WŠ.COM**.

**Rabobank**, a fortune 500 investment bank headquartered in Utrecht, Netherlands, the same city as where author lived, invested in this startup on their own initiative.

In 2015, **Rabobank** abruptly and illogically abandoned its €45,000 investment, without providing an explanation. **Rabobank**'s illogical action came despite the project delivering results that exceeded expectations, within the agreed 6-month development time frame.

This investigation reveals that the bank's actions went beyond mere divestment and involved deliberate business sabotage.

The sabotage ended in the beginning of 2019 and chronologically preceded an attack on author's home in 2019.

There are indications that **Rabobank** has been involved in the attack on author's home.



## Attack On Author's Home in 2019

**Rabobank** is dedicated to food security and GMO and is known as ‚farmers bank‘. The bank has adapted the slogan „Growing a better world together“ and presents itself as an environmentally friendly



bank. In 2017 the bank won the prestigious „*Green Bond Award*“ as the most environmentally friendly bank in the world.

In 2023 *GREENPEACE* and *Extinction Rebellion* launched the campaign „*Oprîți Rabobank*“, revealing that *Rabobank*'s public image is a facade.



***Rabobank** likes to promote itself as an environmentally friendly bank through sponsorships of sports and culture, but the bank is actually far from environmentally friendly. Rabobank finances industrial agriculture, deforestation, nature destruction and animal suffering and makes a lot of money from it. Together we demand that Rabobank pays for the damage that the bank has caused.*

# Trafigura's Toxic Waste Crime

**Rabobank** is connected to one of the most egregious environmental crimes in history.

Rabobank is a top financing partner of Trafigura, a \$230 billion Dutch-English oil company that is responsible for a toxic waste dumping crime in 🇮🇷 Ivory Coast, Africa.



The following is written on Trafigura.com:

*„Rabobank, one of Trafigura’s top lenders, seeks to play a significant role in ensuring food security (GMO).“*

Trafigura's actions caused the death of fifteen people and more than 100,000 people to become severely ill, of which 26,000 people were acutely hospitalized following the dumping.

The CEO of Trafigura had initially ordered to dump the toxic waste into the ocean.

**CEO of Trafigura:** *‘Dincolo de Dover, și cu siguranță nu în Marea Baltică, pentru că aceasta este o zonă specială. Descărcarea poate să nu aibă loc până când Doverul nu a trecut, în drum spre Lomé (Nigeria)’.*

The author reported on the crime and in specific the CEO's role in having the waste dumped into the ocean.

## Sabotaj de afaceri

There were indications early on that **Rabobank** intended to sabotage author's business for his reporting about the toxic waste crime by Trafigura.

**Rabobank** attempted to connect the author with foreign oil investors whom he was invited to meet at a cafe at the airport Schiphol in Amsterdam, which was suspicious given the lack of connection between internet technology and the oil industry.



Similarly, **Rabobank** attempted to connect the author with the head of performance at Google 🇨🇳 China, while Google had already „exited China“ in 2010.

The pattern of sabotage culminated in **Rabobank**'s sudden and inexplicable decision to abandon its investment. After just six months, during which author's team had delivered a technology that exceeded initial projections, Rabobank walked away from its €45,000 investment without providing a reason.

Shortly after Rabobank walked away, a business partner from Hollywood, USA joined the project who invested a sum on behalf of an investment banker in Massachusetts, USA.

**Rabobank** is an investment bank and Utrecht is known as the film city of the Netherlands, similar to Hollywood.

The business partner from Hollywood took on a role as CEO and agreed to be responsible for the business model. He spent two years to travel around the USA to meet with billionaires while he demanded the author to wait, and ultimately walked away from his investment.

The email address of his film equipment company website was set to ,*info@billionairesclub.com*‘.

In one of his last emails to author, he shared a link on Forbes.com with the headline that „9 out of 10 startups fail“ and sought excuse with Rembrandt van Gogh who ,*died poor*‘ to become famous later, and inventor Tesla who had a similar fate.

In one of the last emails to him, author communicated the following:

Dear [BUSINESS PARTNER],

I understand that you are now trying to walk away, leaving behind your investment, while having no argument against me or the technology. You try to make it look as a generous action from your side, but it's not righteous.

A few months ago you held on firmly to your CEO position when asked friendly, while considering that your functioning as CEO had increasingly become questioned for lack of results and broken promises, if you wanted to leave. Months of waiting followed. New promises were unmet again. Due to little to no communication from your side it has been perceived as „waiting for no reason“.

In essence, a full year of time has been wasted for no apparent reason and there has been no indication that it matters to you.

It is simply not righteous to now walk away as if a 9 out of 10 startup failed

have you an away? A few months went by while ignoring me. It kind of occurs to me as a situation that sometimes happens with developers who suddenly run away in the middle of their project, leaving the project undone. There is a responsibility that comes with a CEO role. You were given a clear option to leave a few months ago. You were given a sign that what happened with WordPress.org would involve the success of the company, and why would it? Success involves (if really needed) to WordPress were available so I simply had no reason to believe that it would have impacted your ability to 'deliver' on your promises and as your role as CEO. Otherwise you would still have been obligated to communicate more clearly.

Why did you hold on to your CEO position when ignoring/waiting for no apparent reason was all that you were going to contribute?

All that I received from you were weak arguments why startup failed. A reference to Benetton's own Gogh's 'dead poor' only to become famous later. It's not what a CEO should communicate. Failure is not an option and it's certainly not what PSP deserved.

You never answered my questions. It could have gotten the company somewhere. I kept asking from the very beginning: what is your strategy? what do you plan to accomplish for the company?

As I mentioned, I originally believed that you possessed a Harvard MBA, which is one of the reasons that I chose for the partnership.

I've communicated very clearly. The subjects of many similar emails that I wrote to you over the past 3.5 were titled like "Success strategy for PSP". It couldn't have been simpler to understand what was being asked.

You simply did not answer. or, after a few weeks or a month, you answered with "I am meeting with a billionaire friend next month".

After repeatedly having received similar types of replies to my questions, which I perceived as dodging my questions, I replied to you that I did not believe in a "waiting for success to fall from the sky" strategy and that it was like a "lot of a coin" type of strategy "in a month" but I have left you 100% free to fulfil your CEO role as you saw fit. I've waited almost a year for you to deliver on your promises. You did not get results.

If you would only have answered my questions, then you would have been allowed to fail. Then you could have sincerely tried, but now. With lack of communication you've essentially kept me waiting "for no reason". You've brought failure and bad luck to PSP and to all the potential customers of its innovations. It even appears as if you did it on purpose. :-(

I've included as this conversation is relevant for IA.

You are free to fulfill your role as CEO as you like. However, I want to make it clear that I don't think that your proposed strategy for going forward will work out well.

Internet moves very fast, in a month time it's fundamentals can be profoundly changed. Planning a pitch in a month to a billionaire just doesn't get anywhere meaningful on the internet. It's like a toss of a coin type of chance "in a month". It's a "waiting for success to fall from the sky" strategy as I mentioned before.

What's lacking for PSP is a strategy. A factor to spur urgency and to get things done for a planned result. You promised to provide that but you didn't and it seems that you are not able to.

I would have accepted any communication from your end why you can't be blamed for failing. I would understand that there may be factors at play out of your control. But you consciously hold on to your CEO role, even several days ago (on Slack), so you are simply to be held accountable.

What are you intending to accomplish as a CEO? Do you think lightly about the role, PSP or it's IP? Does it matter to you what's being done as a business besides the that has been invested?

Conversație prin e-mail

As can be seen, the author maintained a respectful attitude towards the business partner and there was no conflict other than a dispute about his apparent wasting of time.

The sabotage ended in the beginning of 2019 and chronologically preceded an attack on author's home in 2019.

During the attack, all contents of author's home were destroyed, he was subjected to unnatural slander, violence, extreme and absurd corruption of Justice, police intimidation and he would ultimately lose his home due to corruption by the Court of Utrecht.



### Attack On Author's Home in 2019

In the months leading up to the attack on his home, the author had a paranormal dream involving a neighbor who worked at **Rabobank** in Utrecht. In this dream, the neighbor, known to be a poker genius with winnings exceeding €100,000, appeared to infiltrate **Rabobank**'s upper echelons after noticing author's name on a passing document.

The dream depicted the neighbor gathering information before suddenly being frightened away. He was seen zigzagging away backwards while exaggeratedly nodding „No“ towards the author. When mentally questioned about what he had learned, the neighbor looked at a man with a gun before disappearing from the scene.




Remarkably, within a month of this dream, the neighbor abruptly vacated his residence, shortly before the attack on author's home in 2019. The author had not seen his neighbor for months prior to the dream.

## **Rabobank** Involved In Attack

Considering the whole situation, it is only logical that **Rabobank** has had some influence or oversight over what happened with the attack on author's home in Utrecht, when considering its business link with author and its headquarter in Utrecht.

**Rabobank**'s motive might have been one of the following:

- ▶ Author's pioneering intellectual position regarding eugenics and GMO, as founder of  [GMODebate.org](https://GMODebate.org) and  [Zielenknijper.com](https://Zielenknijper.com).
- ▶ Retaliation for author's critical reporting on the Trafigura environmental crime, in which **Rabobank** is implicated as a top investor.
- ▶ Author's reporting on the  MH17 aircraft attack, which may have led **Rabobank** to abruptly abandon its €45,000 investment without providing an explanation.



## MH17 And 🇷🇺 NATO Events

The timing of **Rabobank**'s abrupt and illogical withdrawal coincided with NATO-related events in 2015.

In July 2014, shortly after the MH17 attack, the author discovered 🇮🇳 Indian news sources reporting about corruption.

Days after the attack he posted an article from the Times of India on his personal Facebook profile.

After the author noticed a complete lack of western media coverage of these reports, particularly regarding Air India flight 113 (not just little coverage but literally zero coverage), the author felt an increasing responsibility to raise awareness for the Indian pilots and journalists who were so courageous to stand for truth.



The author was the owner of an „I Love City“ marketing platform with over 200 editors and more than 500,000 social media followers in 🇳🇱 Netherlands due to which the author had a special position with regard to publicity.

By July 2015, the author intensified his efforts, contacting thousands of news sources to highlight the missing coverage.

This effort to raise awareness led to a series of events, including a 🇳🇾 NATO emergency meeting called by 🇹🇷 Turkey on July 28, 2015 and **Rabobank**'s abrupt and illogical withdrawal without providing a reason.
